At the completion of the course, participants will be able to:

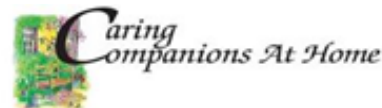
1. Develop a nuanced understanding of dementia care including common misperceptions.
